Market Outlook: U.S. ethanol prices ended last week 2.5 percent higher and extended those gains in early week trading and rose 3 percent through Tuesday's close. Midwest wholesale rack ethanol prices were higher to end last week and were up 2.9 percent through Tuesday's market close to their last quote of 48.6 cents/liter (183.98 cents/gallon).

FOB Houston ethanol prices finished last week 2.2 percent higher and are up 2.1 percent through Tuesday's trading from Friday's close. FOB Houston ethanol prices are quoted at 47.26 cents/liter (178.9 cents/gallon). FOB Santos, Brazil anhydrous ethanol prices were lower last week; they are up in early week trading and rose 5.9 percent to 58.45 cents/liter (221.25 cents/gallon) through Tuesday's close.

The FOB Gulf-Santos, Brazil ethanol spread has widened from last week's close through Tuesday's trading and is currently at -11.19 cents/liter (-42.35 cents/gallon).

MTBE prices fell 5.3 percent last week but pared those losses in early week trading to gain 0.6 percent from Friday's close through Tuesday's trading. MTBE's premium to FOB Houston ethanol has decreased from last week's report and stands at 27.05 cents/liter (102.4 cents/gallon).


BTX component prices were mixed last week but were mostly higher through Tuesday's market close: Benzene was up 1 percent while Toluene was up 1.5 percent, and Xylene was down 0.3 percent. The estimated weighted average aromatic price is currently 101.64 cents/liter (384.73 cents/gallon), up from last Friday's close. The BTX-Houston ethanol spread narrowed last week, and the weighted average BTX price is 54.37 cents/liter (205.83 cents/gallon) higher than the FOB Houston ethanol price.

Gasoline and petroleum products were higher last week but pulled back in early week trade. RBOB futures are down 1.2 percent to start the week while 84 octane RBOB (Houston) and 87 octane CBOB (U.S. Gulf) gasoline prices are down 1 and 1.4 percent, respectively. WTI futures are 1.9 percent lower at \$85.23/barrel while Brent futures are down 1.9 percent to \$89.45/barrel, from Friday through Tuesday's close.

Liquid tanker rates are 2 percent lower on average this week with offers for the U.S. Gulf to Brazil remaining steady amid the broader weakness. Freight from the U.S. Gulf to the East Coast of Mexico saw the largest declines and is down 12 percent from last week. On average, tanker freight from the U.S. Gulf is down 3 percent this week while freight from the PNW has posted a 1 percent decline. Liquid tanker freight rates from Brazil are unchanged, on average, this week. Freight rates across all origins are 11 percent higher than this same week in 2023.


On a cost-and-freight (C&F) basis, offers are mostly higher this week as higher FOB offers for ethanol offset lower freight rates. Prices for ethanol C&F to Central America from the U.S. Gulf are up 2 percent this week and are down 27 percent from this same week in 2023. Values for PNW ethanol to Southeast Asia average \$836.04/MT this week, up 5.2 percent from the prior week but down 8.9 percent year-over-year. That compares to U.S. Gulf to Southeast Asia C&F prices that average \$721.62/MT and are up 2.2 percent from last week but are down 25.2 percent year-over-year. C&F prices for Brazilian ethanol to Southeast Asia are up 0.5 percent from last week.

Rolling 52-Week Ethanol and Gasoline Prices, FOB Houston






Daily Weighted Average BTX and Ethanol Prices, FOB U.S. Gulf



Ethanol as % of Gasoline, FOB U.S. Gulf Prices




FOB Ethanol Prices, U.S. Gulf and Santos, Brazil






Seasonal Trends in Brazil's Anhydrous - Hydrous Ethanol Spread



FOB Gasoline and Ethanol Prices




U.S. Benzene, Toluene, and Xylene Prices and Estimated BTX Value






Seasonal Trends in U.S. Gulf - Santos, Brazil Ethanol FOB Price Spreads




Clean Liquid Tanker Freight Rates to Singapore





