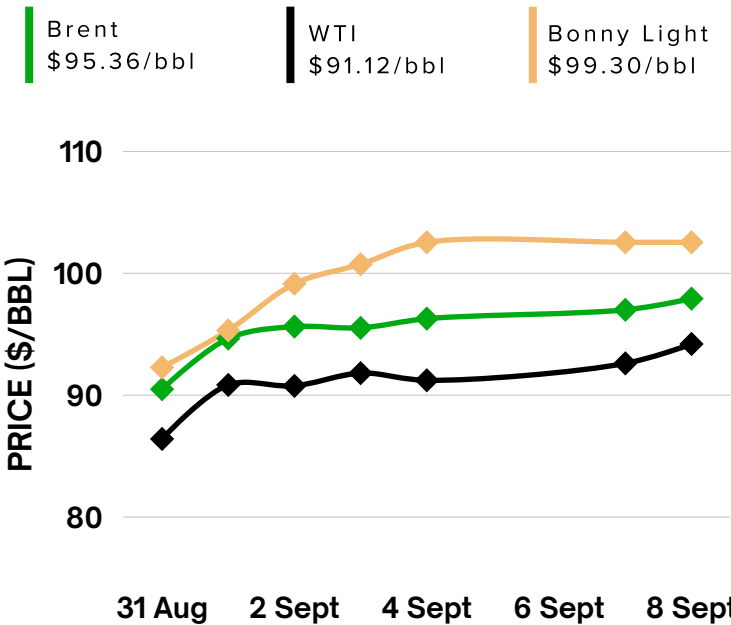

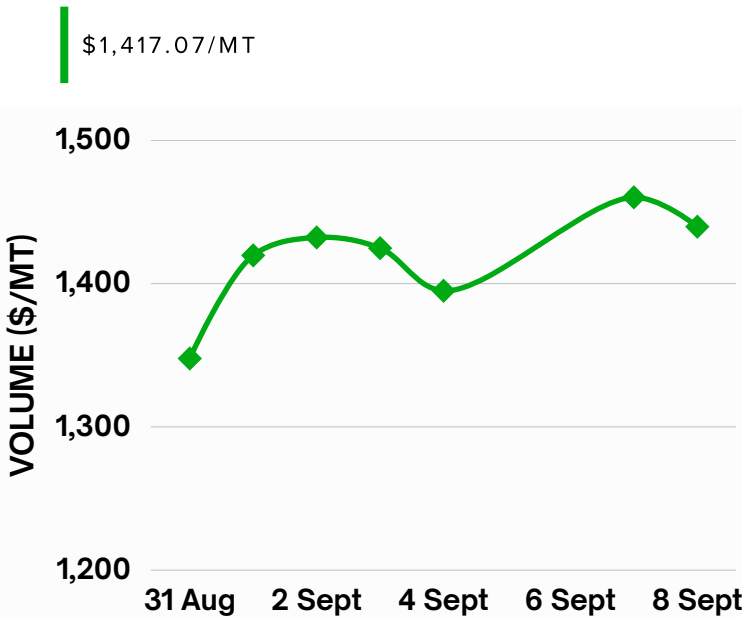
Crude Benchmark

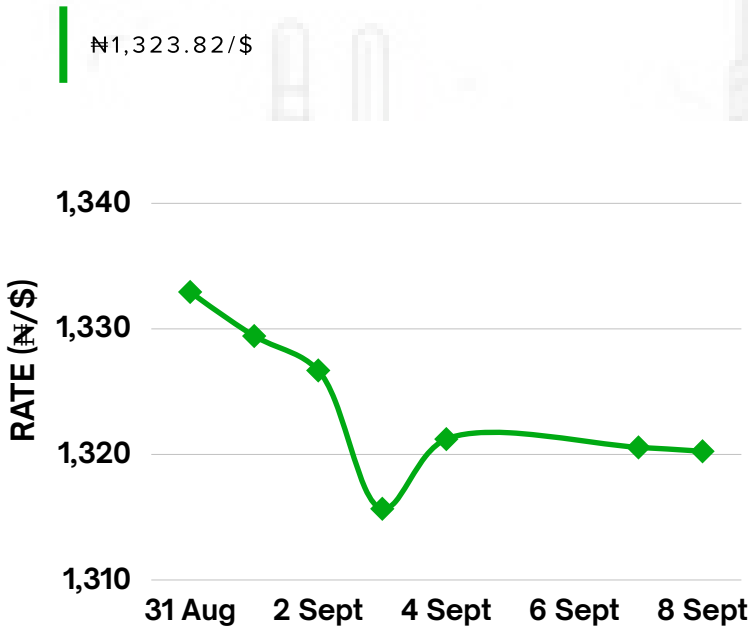

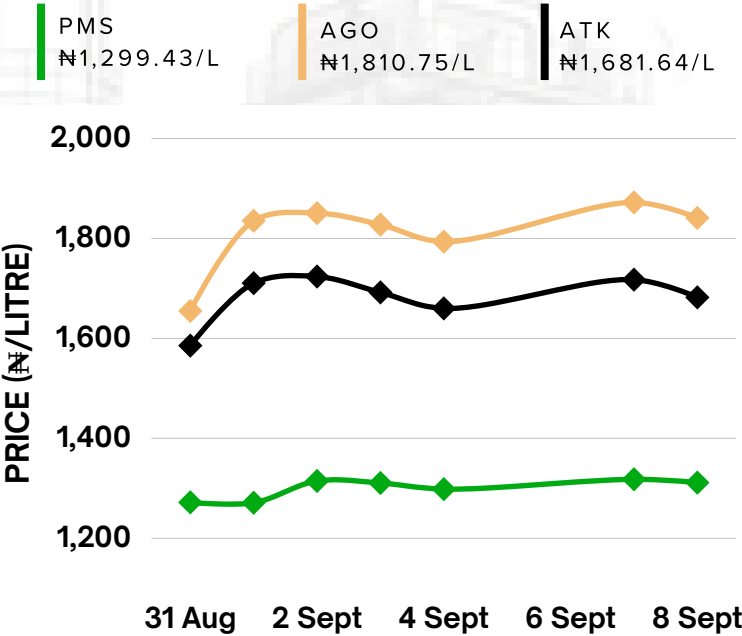
